

PRESENT: Brian P. Zidek, Chair; Dr. Monica Taylor, Vice Chair; Kevin M. Madden, Council Member; Elaine Paul Schaefer, Council Member; Christine A. Reuther, Council Member; Joanne Phillips, Controller; Marianne Grace, Chief Administrative Officer; William F. Martin, Solicitor; Anne M. Coogan, County Clerk.

The Regular Meeting of Delaware County Council was held on July 1, 2020 at 6:00 pm on Zoom and was livestreamed. Chairman Zidek called the meeting to order followed by the Pledge of Allegiance.

Chairman Zidek asked for a moment of silence in memory of William "Brad" Blackman, a Firefighter and EMT from Swarthmore Borough who lost his life due to Covid-19.

Chairman Zidek stated that County Council has been in executive session twice since our last meeting. The first executive session was on June 25 to appoint Councilwoman Reuther as an Interim Chief Administrative Officer until mid-July. Ms. Reuther will not be paid any additional money for this position and all of Council thanks her for the additional duties she is taking on. We also had an executive session on July 1, 2020 to discuss personnel issues and litigation.

PUBLIC COMMENT: Alex Rose, of Delaware County Daily Times, asked questions regarding the appointment of the new Executive Director. Mr. Rose also asked questions regarding Delco Strong 2.

Motion made by Ms. Schaefer to approve Minutes of the Regular Meeting of June 17, 2020 seconded by Ms. Reuther and carried unanimously.

Motion made by Dr. Taylor to approve to Submit Grant Application to the PA Department of Justice for the Internet Crimes Against Children Taskforce in the amount of \$572,731.00 for the term 10/1/2020 through 9/30/2021, seconded by Ms. Schaefer and carried unanimously.

Motion made by Dr. Taylor to Submit Grant Application to Pennsylvania Commission on Crime and Delinquency for Coronavirus Emergency Supplemental Relief in the amount of \$274,377.00 for the term on 1/20/2020 through 1/19/2022. Subject to the Solicitor's approval. This motion was seconded by Mr. Madden and carried unanimously.

Motion made by Dr. Taylor approving to Advertise for Request for Proposals for building cleaning and sanitation services, seconded by Ms. Schaefer and carried unanimously.

Motion made by Dr. Taylor approving of Agreements, Contracts and Amendments with the Human Services Providers of Services as per the attached list, subject to the Solicitor's approval. This motion was seconded by Ms. Reuther and carried unanimously.

Motion made by Dr. Taylor to approve of Agreements with Child Guidance Resource Centers Inc. as per the attached list, subject to the Solicitor's approval, seconded by Ms. Schaefer and carried with an abstention vote registered by Ms. Reuther as she is on the Board of Child Guidance Resource Centers.

Motion made by Dr. Taylor approving of Additional funds from CARES Act proceeds, for Covid-19 expenditures, associated with safe and secure re-opening of county magistrate courts, in an amount not to exceed \$312,000.00. This is estimated costs through December 2020 for State Constables to secure and control the re-opening of the Magisterial District Courts, subject to the Solicitor's approval. This motion was seconded by Mr. Madden and carried unanimously.

Marianne Grace, Chief Administrative Officer, made comments regarding her tenure at the County. Council Madden, on behalf of County Council, thanked Ms. Grace for her years of service to the County of Delaware.

Motion made by Dr. Taylor approving of program parameters developed by the Economic Development Oversight Board with assistance from the Foundation for Delaware County for the maximum \$4,000,000 additional grant funding program to nonprofit businesses previously approved by Council, seconded by Ms. Reuther and carried unanimously.

Motion made by Dr. Taylor to advertise the following Housing and Community Development Action Plan amendment as it relates to the CDBG Program: Allocate an additional \$15,750.00 to Morton Borough for Community Center improvements. CDBG project funds will total \$173,850.00. Subject to a 30-day comment period and Solicitor's approval. This motion was seconded by Mr. Madden and carried unanimously.

Motion made by Dr. Taylor of an Amendment to the 2019 Housing and Community Development Action Plan to include Emergency Solutions Grant – CV and Community Development Block Grant – CV Funds made available under the Coronavirus Aid, Relief and Economic Security Act (CARES Act) in accordance with the attached list. All program activities will be used to prevent, prepare for, and respond to the Coronavirus pandemic and its economic impact. Subject to a 5-day comment period and Solicitor's approval. This motion was seconded by Mr. Madden and carried unanimously.

Motion made Dr. Taylor to install Plexiglass and Lexan barriers in the visitation room, intake area and reception area of the main jail. These barriers will also be installed in the DUI dayroom (visitation area) and entrance area in order to mitigate the spread of the coronavirus in the George W. Hill Correctional Facility for a total amount not to exceed \$66,345.00, subject to Solicitor's approval. This motion was seconded by Mr. Madden and carried unanimously.

Motion made by Dr. Taylor to approve a Professional Services Agreement between the County of Delaware and Aquila Strategy Operations Group, LLC in the amount of \$60,000.00 for the provision of MCM Covid-19 planning, coordination and support with specific focus on All Hazards Preparedness. Subcontractor will work directly with the public health emergency manager to train and develop a Technical Assistance Action Plan as required by the CDC's Office of Preparedness and Response and provide guidance as the county prepares for Covid-19 vaccination distribution, subject to Solicitor's approval. This motion is seconded by Ms. Schaefer and carried unanimously.

Motion made by Dr. Taylor approving to Renew a Professional Services Agreement between the County of Delaware and Aquila Strategy Operations Group, LLC supporting the County's Medical Countermeasure Emergency Program not to exceed \$40,000.00. Contractor will develop an MCM Technical Assistance Action Plan as required by the CDC's Office of Public Health Preparedness and Response, prepare and complete the 2020-21 ORR by June 30, 2021, subject to the Solicitor's approval. This motion is seconded by Ms. Reuther and carried unanimously.

Motion by Dr. Taylor approving of Rules and Regulations for the Delaware County Board of Assessment, seconded by Ms. Reuther and carried unanimously.

Councilwoman Reuther spoke regarding Notes and Summary of Purchases pursuant to the Emergency Declaration.

Ms. Reuther made a motion to amend agenda to add an item for audio visual for the County Council Meeting Room seconded by Mr. Madden and carried unanimously.

Ms. Reuther made a motion to accept proposal from Anixter/Cenero for audio visual/IT infrastructure in the Council room to allow for in house higher quality streaming capability for an amount not to exceed \$55,000.00 seconded by Mr. Madden and carried unanimously.

Solicitor Martin read the First Reading of Ordinance 2020-5 amending Section 6-12 of the Administrative Code to expand the categories of gifts prohibited for Elected Officials and certain employees. Mr. Martin gave a Summary of the Ordinance Amending Section 6-12 of the Administrative Code to Expand the Categories of Gifts which are Prohibited for County Elected Officials and Certain Employees.

The provisions of the proposed Ordinance are summarized as follows:

1. Imposes additional restrictions on the acceptance of gifts by members of Council, the District Attorney, Sherriff, Controller, Register of Wills, Executive Director, County Solicitor, and department heads.
2. Sets forth certain exceptions to such additional restrictions on the acceptance of gifts.
3. Sets forth penalties for violations of such additional restrictions on the acceptance of gifts for County elected official and employees.
4. Describes procedures for reporting and assessing penalties for violations by employees of such additional restrictions on the acceptance of gifts.

Motion by Dr. Taylor to appoint Anthony Moss to the Delaware County Chester Waterfront Industrial Development Authority to a term ending June 2025, seconded by Ms. Schaefer and carried with a 3-2 vote (3 Yeas – Zidek, Taylor and Schaefer; 2 Nays – Madden and Reuther).

Motion made by Dr. Taylor to appoint Jason Rode to the Delaware County Workforce Development Board to a term ending December 2021 representing labor, seconded by Ms. Reuther and carried unanimously.

Motion to table the Approval to appoint 1 member to the Delaware County Workforce Development Board to a term ending December 2021 representing business, seconded by Mr. Madden and carried unanimously.

Motion made by Dr. Taylor to appoint Makeda Hudson to the Delaware County Workforce Development Board to a term ending December 2020 representing government, seconded by Ms. Schaefer and carried unanimously.

Motion made by Dr. Taylor to appoint Lauren J. Footman to the Delaware County Women's Commission to a term ending June 2023, seconded by Ms. Reuther and carried unanimously.

Motion made by Dr. Taylor to appoint Mylisa R. Himmons to the Delaware County Women's Commission to a term ending June 2023 seconded by Ms. Schaefer and carried unanimously.

Motion made by Dr. Taylor to appoint LaKisha Smith Thomas to the Delaware County Women's Commission to a term ending June 2023, seconded by Ms. Schaefer and carried unanimously.

Motion made by Dr. Taylor to appoint Abigail Gertner to the Delaware County Women's Commission to a term ending June 2023, seconded by Ms. Reuther and carried unanimously.

Motion made by Dr. Taylor to appoint Ernesto Aguirre to the Delaware County Board of Assessment to a term ending January 2022, seconded by Ms. Reuther and carried unanimously.

Motion made by Dr. Taylor to appoint Howard Lazarus to Executive Director, seconded by Mr. Madden. Discussion followed. The motion was carried unanimously.

Motion made by Dr. Taylor for the approval of Central Tax Collection Department's request for refunds for the years 2017, 2019, and 2020 County Real Estate Taxes for thirteen (13) property owners due to overpayment of the amount of taxes due, seconded by Mr. Madden and carried unanimously.

Announcement made by Controller Phillips for the Controller's Unclaimed Property Program. Delaware County Controller Joanne Phillips announced the launch of a new website to help residents and organizations recoup the funds they are owed. The website lists the funds, the names of their owners in alphabetical order, the amount, and provides a user-friendly process to claim those funds. If owed money, recipients can fill out a form and mail it in. Forms cannot be submitted by fax or email.

Motion made by Dr. Taylor approving Request by the Controller's Office for payment of current bills seconded by Ms. Reuther and carried unanimously.

SOLICITOR: Mr. Martin spoke regarding the absence of active membership to the Board of Personnel Grievance. I would ask you to consider amending your agenda to do appointments to the Board of Personnel Grievance.

Motion made by Ms. Reuther to appoint members to the Personnel Board of Grievance, seconded by Ms. Schaefer and carried unanimously.

Ms. Reuther made a motion to appoint Vice Chair Taylor, Councilwoman Reuther and Councilwoman Schaefer to the Board of Personnel Grievance seconded by Mr. Madden and carried unanimously.

Mr. Martin informed Council that the County Board of Elections is being sued by the Campaign Committee of Donald Trump. The Solicitor's office will handle the litigation.

Mr. Martin spoke regarding the two outstanding Emergency Declarations, one for Civil Disturbance and one for the Covid-19 Emergency Declaration. I have prepared a termination of the Civil Disturbance Declaration. It is my recommendation that we wait to terminate that Covid-19 Declaration until the County turns to green. Discussion followed.

PUBLIC COMMENT: Carly Sewell, 718 S. Roberts Road, Bryn Mawr, PA made comments regarding Robert "Skippy" Carroll and asked that he be fired for his comments.

Joan Mitchell, Folsom, PA made comments regarding the integrity of the election in November.

Mario Cimino, 46 S. Morton Avenue, Morton, PA: made comments regarding the upcoming election in November and also commented on the Reassessment.

Carl Balis, 100 E. Glenolden Avenue, Glenolden, PA made a comment regarding Open Space in Delaware County.

COUNCIL: Ms. Reuther spoke regarding reassessment notices being sent out. The County's website has been updated that these notices have been sent out and there is information on the website including the appeal information and deadline are on our website. Mr. Reuther also stated Delaware County will be resuming passport services on Monday, July 6. Passport services will be available Monday- Friday from 8:30a.m.-4:00p.m. and on Saturdays from 9:00a.m – noon, with the exception of holiday weekends. There is a \$10 fee for a passport photo. Masks are required for entry and only the applicant (and family members applying for passports) will be permitted to enter the office. Appointments are not being taken.

Ms. Schaefer gave an update on the Bringing Back Delco Program. We have given 1500 PPE kits to our small businesses. Ms. Shaefer thanked everyone who had participated.

Ms. Schaefer also spoke regarding the "COVID-19 Relief Pennsylvania Statewide Small Business Assistance Program" is providing grants ranging from \$5,000 to \$50,000 to small businesses that have been economically impacted by the COVID-19 pandemic.

\$225 million in grant funding is available to small businesses in Pennsylvania to help with COVID-19 related economic losses. \$100 million in grants is available through the Main Street Businesses Revitalization Program. An additional \$100 million in grants is available through the Historically Disadvantaged Business Revitalization Program. Businesses can apply to participating PA Community Development Financial Institutions to access the grant programs.

The application window for the first round of funding opened yesterday and will remain open for 10 business days. Applications will continue to be accepted after 10 business days but will be considered for future rounds of funding. Additional rounds will be announced soon. This is not a first-come, first-served program. There will be multiple rounds of application windows. More information can be found on the County's website. Look for COVID-19 updates on the home page.

Ms. Schaefer also spoke regarding the Sustainability Commission. Delaware County is looking for residents to serve on the newly created Delaware County Sustainability Commission. In February, Council unanimously voted to establish the Commission. The Commission would be addressing best practices in conservation and sustainability. The Commission will be comprised of members of local government and members of the public with expertise in environmental issues and open space. The County is accepting applications to join the Delaware County Sustainability Commission.

Lastly, Ms. Schaefer stated This afternoon Governor Tom Wolf announced a new order signed by Dr. Levine. Under the order, signed under Dr. Levine's authority under the Disease Prevention and Control Act, masks must be worn whenever a person leaves their home. The order takes effect immediately. This includes outdoors areas if you cannot maintain a 6-foot distance and any indoor location where the public is permitted. Wearing a mask is essential to stopping the recent increase in COVID-19 cases throughout the Country including in Pennsylvania. Hot spots have been traced to situations where Pennsylvanians were not wearing masks or practicing social distancing. Please wear your mask and use common sense.

Mr. Madden spoke regarding wearing masks. We do not want to go backwards. The virus is still out there, and we need to be cognizant of that. My mask protects you and your mask protects me. Please be kind and wear the mask. We are all in this together.

Dr. Taylor had one announcement stating Delaware County will be offering drive-thru and walk-up COVID-19 testing for residents on July 9, 10 and 11 in Yeadon. Residents over the age of 18 with COVID-19 symptoms and/or known exposure will be eligible to be tested, especially those at higher risk including residents over the age of 65 and those with pre-existing health conditions. Critical and essential workforce are considered a priority for getting testing. These individuals include first responders, healthcare system employees, grocery stores, pharmacies and other essential workers. Testing will be conducted by trained medical staff utilizing a nasal swab (PCR) testing. Testing is free of charge for residents. Those with private or public health insurance will be asked to provide their insurance card. Residents are asked to wear a mask/face covering. Upon arrival, patients will need to complete a registration form and a consent form. Test results will take up to 5-7 business days. Residents will receive their results by mail. Residents who test positive will also receive a call from the Chester County Health Department. More information on Covid-19 testing, symptoms and resources can be found on the County's website.

Mr. Zidek asked all residents to wear masks. Mr. Zidek stated it is the easiest thing to do. Over the next few weeks you will see changes from County Council. Big changes are coming, and we appreciate everyone's support and consideration as we enact changes. If residents have comments or suggestions, please feel free to reach out either in our meetings or in our offices.

There being no further County business, nor public discussion, Motion made by Ms. Schaefer to adjourn the meeting, seconded by Mr. Madden and carried unanimously.
