• 04/22/2024 08:25 AM, (Medical Emergency)

Officers assigned to the 69th Street Division received a call for a medical emergency in the building. Officers assisted ambulance paramedics in locating the subject in need of medical care and then assisted in escorting the paramedics back to their ambulance with the patient for transport.

Officers assigned to the Courthouse Complex found a bag of what appeared to be marijuana inside of an individual's belongings while screening them into the building. The individual was issued a warning and the marijuana was confiscated and submitted to be destroyed.

• 04/22/2024 2:19 PM, (Narcotics – Possession)

Officers assigned to the Courthouse Complex Bicycle Patrol observed an individual smoking what appeared to be marijuana on Courthouse property. Officers stopped the individual to investigate the matter. The individual turned over the marijuana to officers and their information was obtained.
