Delaware County Council has initiated planning for the Program Year (PY) 2024 Community Development Block Grant (CDBG) Program. The County anticipates that approximately \$525,000 in CDBG funding will be available to support Non-Profit Public Service activities in the upcoming program year, which is scheduled to begin on July 1, 2024.

Those interested in applying for funding must forward an application package to the Delaware County Office of Housing and Community Development (OHCD) no later than 4:30 p.m., Friday, January 5, 2024.

All CDBG Application forms and instructions are now available for digital download on the OHCD website. Fillable PDFs have been incorporated to facilitate completion. Please note that forms requiring initial/signatures must be printed, signed and **original copies are required.** OHCD recommends that applicants use the Application Checklist to ensure that all relevant forms and documentation are submitted. Incomplete submissions will not be considered for funding.

All Non-Profit applicants must submit 1) the Summary Form, 2) the Core Application, and 3) Non-Profit Attachment. Additionally, the following attachments/forms must be submitted based on the type of service/project:

- For Public Service activities, include the Public Service Attachment.
- For <u>Capital Improvements and/or Historic Preservation</u> include the PF&I Attachment and proposed budget.
 Also, applicants <u>must</u> contact Philip Welsh, Director, at 610-891-4014 or <u>welshp@co.delaware.pa.us</u> to arrange a Pre-Application Meeting.

Please note the following:

- Applicants awarded PY 24 CDBG funding are <u>required</u> to attend an OHCD-approved Fair Housing Training during the program year. Failure to do so will impact future eligibility for CDBG funding.
- Non-Profit applicants are required to obtain a Board-approved Resolution in support of the CDBG funding application proposal. Meeting minutes and the Resolution <u>must</u> be submitted with the application.
 - Failure to submit meeting notes and a copy of the Resolution will impact current and future eligibility for CDBG funding.
- Applicants for Non-Profit Capital Improvement or Historic Preservation activity funding are strongly
 encouraged to seek local municipal support by making a presentation to their local municipal council and
 submitting a letter of support with the application.
- Applicants may submit an application for one (1) activity.
