II. Emergency Management Resource:

In the event of Hospital closures, Delaware County will issue a Declaration of Disaster Emergency and will activate the County Emergency Operations Center. Closures of Crozer and Taylor Hospitals, along with the loss of Crozer EMS has potential to not only impact our County, but also the Southeastern Pennsylvania Region, and surrounding geographical area. Links are provided below to example Declaration of Disaster Emergency Initial and Ongoing templates. PEMA currently lists the

thresholds to meet the criteria for Public Assistance for the SFY 2024-2025 as \$2,722,637.60 for the County, and \$24,575,120.00 for the Commonwealth.
