
Administration

 - DCHD alongside all our county departments supporting transition. DCHD's timekeeping's system (UKG/Kronos) will need to sunset and transition to Workday.
 - Customer Confirmation Sessions to review current build and setting were completed in February.
 - Configuration Unit Testing (CUT) is currently underway until the end of March.
 Awaiting release of assigned testing steps that will need to be completed by DCHD.

- Qualtrics contract ends in December 2025; evaluating alternatives for cost and functionality for surveys and Wellness Line ticketing.



3. Highlights/Successes

- We received Delaware County's 2024 School Immunization Law Report (SLIR) from the state. In 2023, there were 24 Delaware County schools who did not report, 10 of which were public schools. Thanks to the outstanding work of Marie Dore, DCHD's Immunization Health Consultant, in 2024, there were only 10 non-reporting schools and there were NO public schools on the list. We are receiving very positive feedback about DCHD Personal Health team's ongoing support to our county's schools.
- DCHD successfully awarded \$120,000 supplemental immunization grant, as noted above in new business.





o HRSA Updates:

Cold Storage Initiative. DCVD is continuing to implement this initiative to alleviate food insecurity in Delaware County. DCHD accepted applications from local non-profit organizations interested in purchasing cold storage equipment for food pantries. The first refrigerators/freezers were delivered in February 2025. The first was delivered to Loaves





and Fishes Food Pantry in Prospect Park, and the second was delivered to Murphy's Market in Upper Darby. Four additional community pantries are approved for cold storage units.

3. Highlights/Successes

- Dr. Key and Rasheeda Williamson's abstract to NAACHO on DCHD's Test and Go public health kiosk program for the July 2025 national annual conference was accepted.
- DCHD is excited to be moving forward with the Delco Revive and Test and Go kiosk expansion projects awarded funding under Delaware County's opioid settlement. DCHD negotiated new contract terms that will expand the county's kiosks to 5 locations at the same cost as 3 locations previously. In April, the two new kiosks will be placed in the

county, one at Delaware County Community College in Middletown and one at SEPTA's 69th Street terminal in Upper Darby. Gun locks provided at no cost to the County District Attorney's office will also now be available in all kiosks starting in March 2025.

- Enhanced coordination and training with DCHD Disease Investigation Specialists in dayto-day operations including and not limited to reportable diseases, outbreak investigations, outbreak tabletop exercises, and quality assurance activities.
- Assessing Sexually Transmitted Infections (STIs) investigations' outcomes, especially regarding cases' pregnancy status, and identification of who, where, when or STI associated risk factors.
- Conducting joint DCHD and PA DOH epidemiology staff quality assurance of datasets derived from PA National Electronic Disease Surveillance System (PA NEDSS).
- Responded to technical assistance requests from the lead coordinator of the Health Care Improvement Foundation, Regional Community Health Needs Assessment (rCHNA) project.
- Accepted invitations to present on Vaccine Hesitance at the Allegheny County Immunization Coalition Meeting in March 2025 and epidemiology and prevention of childhood reportable/infectious diseases presentation for the Delaware County Department of Human Services.
- o Increased DCHD's surveillance capacity regarding Avian flu and influenza outbreaks.
- Planning basic evaluation strategies regarding the effectiveness of DCHD Kiosks' STI product demand and utilization.
- Planning for three members of DCHD Epidemiology Division to pursue Certification in Infection Control (CIC) course and exam.
- Evaluating HIPAA compliant survey software options with improved multi-language capabilities.

3. Highlights/Successes

- DCHD Epidemiology technical support to the City of Chester resulted in a successful healthy homes/lead mitigation grant award of \$350,000 to the city. DCHD provided support on the grant needs assessment, work statement, and evaluation plan. In addition, DCHD Epidemiology technical support to DCHD Personal Health on needs assessment, work statement and evaluation plan resulted in a successful vaccine education grant award to DCHD of \$120,000.
- Facilitated access and coordination of PA Pregnancy Risk Assessment Monitoring System (PRAMS) data sets (PRAMS is a surveillance system developed to reduce infant morbidity and mortality by influencing maternal behaviors before, during, and after pregnancy)
- Established networking relationship with the PA DOH Oral Health Program, Chronic Diseases Epidemiologist, and Chester and Delaware counties dental societies
- Developed a mutually nurturing communication channel with multiple long term care facilities including assisting nurse preventionists in disease control and reporting of outbreaks.

Communications

1. Old Business

- Successfully launched Lead Free 123 lead poisoning awareness campaign.
 - Secured analytics and meta business profile access.
 - Art and elements for Clear Channel Billboards and bus shelters were submitted.
 All buys were installed the week of 2/17. Some were delayed because of wind conditions.
- Supplied Ceisler Media with feedback for one pager and provided graphic elements for Test and Go kiosk, Delco Revive, Vector Borne Illness Surveillance.
- Met with Inzpire to strategize ad creation for 69th street domination campaign. The station domination campaign package included (25) Two-Sheets poster ads (12) Light Pole Banners (8) Station Kings(large banners) and (8) Digital Platform Screens.
 - The purchase of this campaign is mainly to promote the resources available in one of the two new Test and Go Kiosks. One being installed inside 69th St. station where all of these ads will be. There will be no other non-digital ads from other companies that would compete with DCHD's for attention. We can also advertise general health department info like DCHD's wellness line or clinical services available.

2. Highlights/Successes

DCHD LeadFree123 campaign getting great visibility and is encouraging partners such as local municipalities to collaborate on this issue. DCHD collaborated with the City of Chester Health Officer and Children First to present on this topic in the Mayor's Lecture Series in March 2025. This led to Chester City officials participating in DCHD's sponsored lead risk supervisor, risk assessor, and inspector classes later in March 2025, which will support the City's ability to enforce their local lead ordinance. After a presentation by the DCHD team in March 2025, Lansdowne Borough Councilperson commented that the DCHD team knocked it out of the park with stats, facts, and everything, and they were fired up to help their community.
