Officers found the disturbance to be two individuals inside of the office engaged in a verbal argument. Officers separated the individuals, but one of the two individuals would not calm down after attempts being made by the officers to deescalate the situation. Officers eventually detained the irate individual for disorderly conduct and transported them to Park Police Headquarters for processing.
