WEEKLY POLICE BLOTTER

*The below captions are a summary of significant police responses during the listed week. The blotter does not include all calls for service attended to by the Delaware County Park Police Department.

• 01/22/2024 10:00 AM, (Disturbances)

Officers assigned to the Courthouse Complex were dispatched to a report of a disturbance outside of one of the courtrooms. Arriving officers found there to be no disturbances in the area. A passerby in the area advised that two individuals had been arguing prior to the officer's arrival and had exited the building on their own. Officers remained on scene for a short time to ensure there were no other issues in the area.

Arriving officers met with an individual that was irate about a domestic relations issue. A case worker spoke with the individual and explained everything to them regarding their case. The individual still did not calm down and officers had to de-escalate them before escorting them out of the building for the day.

Officers assigned to Chester Probation detained and arrested an individual with an active Violation of Probation warrant.
