WEEKLY POLICE BLOTTER

12/08/2024 – 12/14/2024

*The below captions are a summary of significant police responses during the listed week. The blotter does not include all calls for service attended to by the Delaware County Park Police Department.

• 12/09/2024 12:19 PM, (Weapons Possession)

Officers assigned to the screening area of the 69th Street Human Services building located and confiscated a pair of brass knuckles being carried by an individual checking into the facility. The individual was advised that brass knuckles are a prohibited weapon and was issued a warning.

• 12/09/2024 2:45 PM, (Disturbances)

Officers assigned to the Courthouse Complex responded to a report of a disturbance outside of one of the courtrooms. Arriving officers met with 3 individuals who were reported to have been engaged in an argument before officers arrived. Officers gathered information from all parties involved and escorted them out of the courthouse from separate exits.

• 12/09/2024 5:30 PM, (Medical Emergency)

Officers assigned to the Fair Acres Division received a call for a medical emergency in Building 8. Officers assisted the Riddle Hospital ambulance paramedics in locating the subject in need of medical care and then assisted in escorting the paramedics back to their ambulance with the patient for transport.

• **12/10/2024 08:44 AM, (Weapons Possession)**

Officers assigned to the screening area of the courthouse building located and confiscated a pair of brass knuckles being carried by an individual checking into the facility. The individual was advised that brass knuckles are a prohibited weapon and was issued a warning.

• **12/10/2024 10:39 AM, (Narcotics – Possession – Marijuana)**

Officers assigned to the Courthouse Complex observed an individual place something near the entrance of the adult probation entrance before entering the building. Officers investigated what the discarded item was and discovered that it was a bag containing what appeared to be marijuana. The suspected marijuana was collected for evidence and to be tested as well as the individual's probation officer being advised of the situation. Following this, the individual was arrested for a violation of probation warrant and transferred to Delaware County Prison pending additional criminal charges.

Officers assigned to the Sharon Hill Probation Office detained and arrested an individual with an active Violation of Probation warrant.

• **12/11/2024 11:00 AM, (Wanted Person)**

Officers assigned to the Chester Probation Office detained and arrested an individual with an active Violation of Probation warrant.

• **12/11/2024 4:50 PM, (Medical Emergency)**

Officers assigned to the Fair Acres Division received a call for a medical emergency in Building 8. Officers assisted the Riddle Hospital ambulance paramedics in locating the subject in need of medical care and then assisted in escorting the paramedics back to their ambulance with the patient for transport.

• **12/12/2024 2:06 PM, (Disturbances)**

Officers assigned to the Courthouse Complex responded to a report of a disturbance outside of one of the courtrooms. Arriving officers met with 2 individuals who were reported to have been engaged in an argument before officers arrived. Officers gathered information from all parties involved and escorted them back into their assigned courtroom and monitored the remainder of their case to ensure no other incidents occurred.

• 12/13/2024 3:20 PM, (County Park Ordinance Violation)

Officers assigned to Parks Patrol observed a vehicle enter Rose Tree Park through the main entrance and cut through the park to the side entrance before exiting to Rose Tree Road. Officers conducted a traffic stop and advised the driver of the vehicle of the County Park Ordinance Violation before issuing a warning and releasing them.
