WEEKLY POLICE BLOTTER

*The below captions are a summary of significant police responses during the listed week. The blotter does not include all calls for service attended to by the Delaware County Park Police Department.

• 03/17/2024 6:52 PM, (Medical Emergency)

Officers assigned to the Fair Acres Division received a call for a medical emergency in Building 6. Officers assisted the Riddle Hospital ambulance paramedics in locating the subject in need of medical care and then assisted in escorting the paramedics back to their ambulance with the patient for transport.

• 03/17/2024 4:01 PM, (Disturbances)

Officers assigned to Parks Patrol responded to a report of threats in progress with a fight about to occur at Upland Park. Upon arrival, officers from Parkside Borough and Upland Borough Police Departments encountered multiple individuals who fled throughout the park. Officers chased the individuals and detained two individuals connected to the call. Upon officers from the Delaware County Park Police Department arriving to the scene they took statements from the reporting parties while the officers from Parkside and Upland transported the other individuals involved to be booked into custody.

Officers scanned the dog for an identification chip and found no results. There were no identifying tags on the dog and officers took custody of the dog and began contacting local resources to help. Officers eventually transported the dog to the Brandywine SPCA who took custody of the dog for longer term care.

Officers assigned to Sharon Hill Probation detained and arrested an individual with an active Violation of Probation warrant.
