WEEKLY POLICE BLOTTER

*The below captions are a summary of significant police responses during the listed week. The blotter does not include all calls for service attended to by the Delaware County Park Police Department.

• 03/04/2024 09:50 AM, (Panic Alarm)

Officers assigned to the Courthouse Complex responded to a report of a disturbance inside of one of the courtrooms. Upon arrival officers found an individual fighting with Sheriffs Deputies and assisted in getting the individual into custody. Following this the individual was transported to the Courthouse Cell Block and criminally charged.
