WEEKLY POLICE BLOTTER

*The below captions are a summary of significant police responses during the listed week. The blotter does not include all calls for service attended to by the Delaware County Park Police Department.

• 06/09/2024 7:26 PM, (County Park Ordinance Violation)

Officers assigned to Parks Patrol found swimmers in the water at Kent Park during a routine patrol of the park. Officers advised the swimmers to exit the water and informed them that swimming is prohibited there due to the safety issues and no lifeguard being present. The swimmers were issued a warning and released.

• 06/10/2024 10:10 AM, (Disturbances)

Officers assigned to the Courthouse Complex responded to a report of a disturbance outside of the complex. Arriving officers met with an individual who had reportedly made threats to a Public Defender following a court case. Officers obtained information and a statement from all parties involved and released the individual who had made the alleged threats with a warning.

Officers assigned to the Courthouse Complex responded to a panic alarm activation in one of the offices inside of the complex. Arriving officers met with an individual who advised that they had accidentally activated the alarm. Officers took information and cleared the scene.

Officers assigned to Sharon Hill Probation detained and arrested an individual with an active Violation of Probation warrant.

• **06/12/2024 10:50 AM, (Weapons Possession)**

Officers assigned to the screening area of the Courthouse Complex located and confiscated a pair of brass knuckles being carried by an individual checking into the facility. The individual was advised that they are a prohibited weapon and was issued a warning.
