WEEKLY POLICE BLOTTER

*The below captions are a summary of significant police responses during the listed week. The blotter does not include all calls for service attended to by the Delaware County Park Police Department.

• 06/03/2024 08:43 AM, (County Park Ordinance Violation)

Officers assigned to Parks Patrol received a report of multiple dogs off of their leashes in Rose Tree Park. Upon officers met with the complainant and were advised that the dogs in question were now on their leashes. Officers remained at Rose Tree Park and conducted foot patrols to ensure all visitors were following the park ordinances.

• 06/03/2024 10:00 AM, (Narcotics – Possession – Marijuana)

Officers assigned to the Courthouse Complex found a marijuana vape pen inside of an individual's bag while screening them into the building. The individual advised that they did not possess a medical marijuana card on them. The individual was issued a warning and the marijuana was confiscated and submitted to be destroyed.

• 06/03/2024 4:46 PM, (Weapons Possession)

Officers assigned to the screening area of the Courthouse Complex located and confiscated a pair of brass knuckles being carried by an individual checking into the facility. The individual was advised that they are a prohibited weapon and was issued a warning.

• **06/04/2024 10:00 AM, (Wanted Person – Resisting Arrest)**

Officers assigned to the Courthouse Complex assisted Sheriff's Deputies in detaining an individual with an active arrest warrant. In the Process of the arrest the individual became combative and attempted to flee from custody. Officers and deputies eventually succeeded in subduing the individual and transported them to the George W. Hill Correctional Facility for housing.

• **06/04/2024 1:00 PM, (Narcotics – Possession – Controlled Substance)**

Officers assigned to the Courthouse Complex found an assortment of pills inside of an individual's cigarette pack while screening them into the building. The individual was taken into custody while officers identified the pills. The recovered pills were field tested to determine what they were and submitted as evidence. The individual was charged for the possession of a controlled substance and released from police custody.

• **06/04/2024 7:00 PM, (Medical Emergency)**

Officers assigned to the Fair Acres Division received a call for a medical emergency in Building 6. Officers assisted the Riddle Hospital ambulance paramedics in locating the subject in need of medical care and then assisted in escorting the paramedics back to their ambulance with the patient for transport.

• **06/05/2024 07:54 AM, (County Park Ordinance Violation)**

Officers assigned to Parks Patrol observed a vehicle enter Rose Tree Park through the main entrance and fail to stop at a posted stop sign. Officers conducted a traffic stop and advised the driver of the vehicle of the County Park Ordinance Violation before being released with a warning.
