(Specifically recent contact regarding which workers intend to report November 3rd ) Contacts should be made directly to the elected Judges and Inspectors first wherever possible (and it certainly is for those of us whose emails the Bureau has) before utilizing these power brokers. We were elected to these offices, not appointed by a political party chair. I think that severing the direct connection between the local boards and the BOE is a mistake. I don't think it is in the interest of maintaining poll workers' motivation to continue their duties.

Dear Ms. Lunkenheimer and Messrs Byrne and Lawrence:

This is a quick note to ask you to contact relevant PA legislators to request that local election officials be allowed to start processing ballots as they are received instead of waiting until Election Day. This is particularly important with 3 million Pennsylvanians expected to vote by mail this fall. This should include notification to voters of any errors in the ballots when there is still time to make corrections or to vote in person.

In addition, although County Council has obtained funding for placement of additional election drop boxes in each municipality, some legislators apparently want to ban drop boxes entirely. When you contact the legislators, please seek their commitment to oppose any restriction on the use of drop boxes.

Delaware County Council, the Elections Board and staff did a heroic job in getting ballots mailed and processed for the primary. Thank you for your continued efforts to protect our democracy and the right of every citizen to vote in safety, with the assurance that our votes will be counted.

I would like to submit the following questions and feedback for the September 3rd Board of Elections meeting:

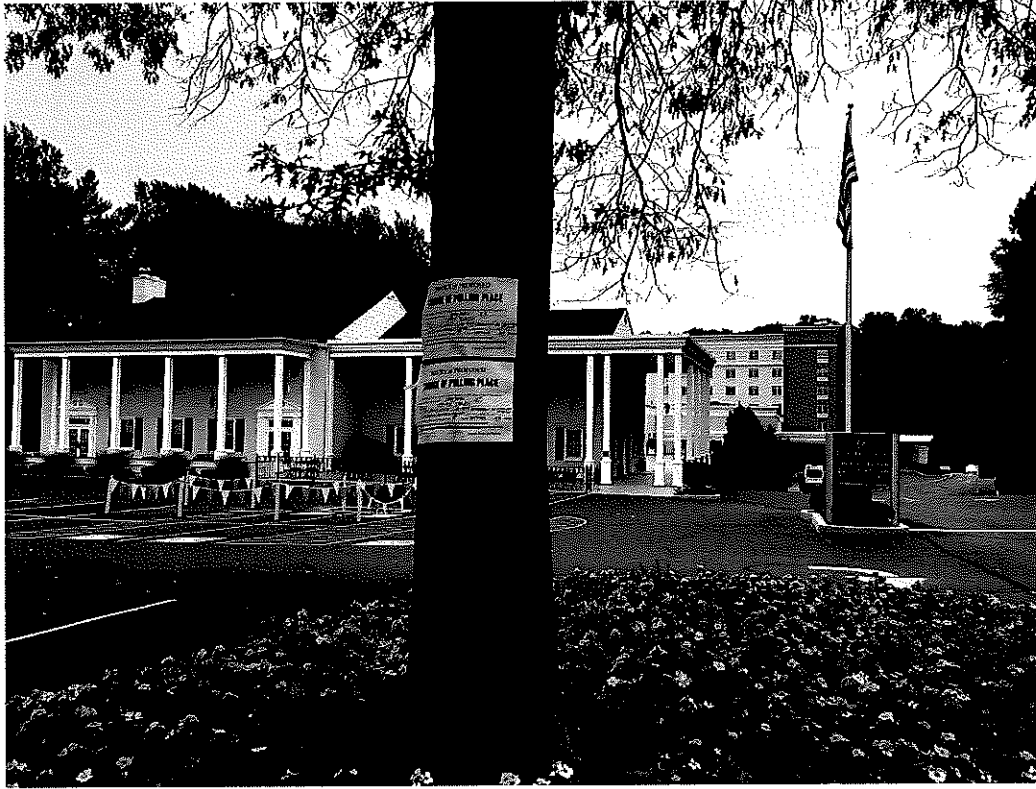
My polling place is The Drexelbrook Club. I was driving past and saw a notice posted to a tree about the petition to change this polling place.

My name is John Vizzarri and I am resident of Drexel Hill, Upper Darby Township in Delaware County.

I am not a fan of overall mail in ballots other than the absentee ballot that requires an acceptable and approved reason why someone can not vote in person. However with that being said, I have a several questions and concerns that I would like answered with regards to the upcoming 2020 General Election, because what I observed during the 2020 Primary Election

First and foremost, I felt the new paper ballot is totally archaic especially in the year 2020. While I understand the need for a paper trail to be able to reconcile I was not comfortable during the Primary that my paper ballot was NOT scanned at the polling location. I do not believe that my VOTE being entered into a system of record should be dependent upon someone else other than myself, and I hope that for the 2020 General Election the scanner will be at the polling locations.

Additional concerns that I had with the 2020 Primary, was that at the polling location the box in which the paper ballots were placed was under the control of a single individual with sole access to the key of the one lock that was on the box. This is totally unacceptable and does not mitigate the risk of that one individual accessing the box on their own unobserved and able to remove ballots.

As far as mail-in-ballot process:

- No person who signed up for MAIL-IN-BALLOTS should be permitted to drop off their paper ballot at the polling location. If they can get to the polling location then they are able to vote in person.
- What are the controls in place to mitigate the risks of handling the paper ballots, especially mail-in-ballots?
- Mail-in-Ballots applications should not be accepted after an appropriate pre-determined amount of time to allow for proper vetting and processing and for the voter to receive and return their ballot prior to election day.
- No mail-in-ballot should be counted after ELECTION DAY. That is why mail-in-ballots should be required to be post marked and received prior to election day, (possibly 7 calendar days) prior so that there is ample time to validate and then have them ready and secured for scanning into the system of record on election day.
- How will the drop boxes that you voted on going to be controlled? How does that prohibit ballot harvesting by a political party of member of the community? How are they going to be secured? How often will ballots be removed and under what type of control will they be removed? No citizens vote should be handled by a third party
- How do you ensure that the physical paper ballot was actually completed by the registered voter? I understand the registered voter has to sign the envelope but that does not guarantee that they indeed made the selection marked on the ballot.

What I witnessed during the Primary was horrible. I observed your video feeds of ballots being handled by individuals. Yes while there were cameras on the people handling the ballots I watched and saw ballots placed on the floor, trays handled and transported by a sole individual etc. Using banks as an example, while there are cameras all over within a bank branch employees are still required to adhere to DUAL CONTROL or DUAL OBSERVATION/PARTICIPATION. Access to Vault Cash/ATM Cash is not handled by one individual even though cameras are in the work area. Furthermore, I saw photographs on social media where the ballots being transported from the polling location to Media, PA for processing were left on the street because of the back up in traffic and long waits. I'm

not sure if the people transporting the ballots are doing so by themselves but again, ARMORED CARS do not just have one person delivery or picking up cash from banks and commercial entities.
